Requirements

- Each artist can submit 2 to 3 paintings.
- Only Chinese Brush Painting will be accepted. The media used should be ink, Chinese pigments, and/or Japanese pigments on oriental paper (rice paper, Japanese paper and Korean paper) or silk.
- Use acrylic sheet rather than glass for framing (to minimize potential hazard liability).
- Framing work should be done in professional fashion (no poster frames, please). If possible, the matting of each painting should be at least 2” wide.
- The restaurant owner will select the paintings for display.
- The commission is set to 10% of the sale price. If the buyer pays with credit card the commission is 13.5%. Please take these commission rates into consideration when you set the price for your paintings.
- Exhibit length is three months.
- Paintings must be original artwork and not copies of other artist’s paintings, unless a study piece is acknowledged in the painting’s title.

How to apply

1. Fill out the application form on page 3.
2. Cut out the label below, fill out the information, and place on the back of each painting.
3. Deliver your paintings along with application form to Peking Palace on one of the drop-off dates listed on page 2.
